Editorial - APATHY

Both the Central and Sate budgets have come and gone. May be we have to wait for future sessions for placing the bill of National and State Policy for Older Persons ie. Senior Citizens. National Policy was announced in 1999. But well before it was enacted, many political changes have taken place and the policy itself is deeply buried in the auise of revision, re-revision. re-re-revision etc. The case with TN Govt is different. It never surfaced though attempted a few times.

The policy is an indicator of all the areas of well being related to Senior Citizens. The Govts are hence implied automatically to implement. That could be the reason to shy away from announcing the policy itself. The implementation of maintenance of Parents and Senior Citizens Act 2009 is still hanging in fire, in TN and many other states. Delay in providing safety and security of senior citizens by Police & Revenue Depts as well as delay in giving effect to many laudable provisions by Social Welfare Dept have been guestioned by Madras High Court. Also the State Apex body (now head less) under maintenance act has not even met once. Senior Citizens Bureau has been consistently drawing the attention of Govt, in many forums including TN Govt State Planning Commission to the prevailing lacuna.

In this context, we welcome and call upon the newly formed "Dr V S Natarajan Geriatric Foundation" to give thrust to the foremost needs of the hour. Padmasri Dr V S Natarajan being the doven of Geriatric Medicine deserves applause to form this Voluntary Organization at the age of 78. It is declared that he is the Chairman, partnered with an young adult Thiru M. Rajasekaran as the Managing Director. It is not clear under which category it is registered, a Corporate, Trust or Association. We warmly appeal to the Foundation to strengthen the pinnacles of a social organization for administering public cause, without giving room for glamour, self promotion and commercial value. All aspects of ageism and age care issues have to be addressed. There is no reported focus on Senior Citizens Policy, Maintenance Act, State Apex Body, Safety, Social Security and Regulation of Old Age Homes in recent interactive public deliberations with the Govt. The Chairman, recipient of many awards is a member of State Apex Body and Patron of many Senior Citizen Associations and Federations. His voice will be valuable and noticeable. •••

1)What to do when we suspect someone to have dementia? Please contact your family doctor, geriatric neurologist or psychiatrist.

How to prevent dementia?

Keep good Health, well balanced diet, regular exercise, managing high blood pressure, diabetes and heart diseases accordingly' with doctors care. Lastly give up smoking and less or no alcohol.

Mental Health Bill - Right of Mental illness patients to live in the community

The Mental Health Bill passed on Monday in the Lok Sabha is expected to revive the way mental illnesses are dealt with in the country. While the Bill has been termed progressive by the fraternity, a particular clause that emphaises advanced directive from the patient has been debated widely. Pune –based psychiatrist Dr. Saumitra Pathare, who had drafted the Bill along with Professor Jaya Sagade, said the Bill would turn good lot of aspects in the mental health care." For the first time, there is an emphasis on rehabilitation within the community. The Bill talks about the patients' right to live within the community and not in seclusion. This changes the perspective with which we look at mentally ill patients," said Dr. Pathare, adding that the bill had a clause that mandated the government to increase the number of mental health workers.

Ire over ECT: The bill probhibits Electro Convulsive Therapy (ECT) for minors. In adults, ect can be given only after the use of anaesthesia or muscle relaxant. The bill also restricts medical institutions from chaining patients or keeping them in seclusion. The bill states that a mentally –ill person shall have the right to make an advance directive that states how he wants to be treated and who his nominated representative shall be. "However, this is an dicey clause. How will a person who has illusions, or feels that everyone is conspiring against him or her, be in the state to give such a consent," asks pschatrist Dr. Dr. Saumitra Pathare. *Courtesy: The Hindu dated 29.03.17*

Impairment of cognitive ability and motor function is an indicator of dementia. We have to keep the millions of cells in the brain alive by ensuring adequate supply of oxygen and blood, with active work for the brain in the old age. He cited the efficient functioning of brain and other faculties of great thinkers, leaders and social
