
- 5) The file for renewing the society registration has been duly submitted to the Registrar on 11.05.17. EC approved the expenditure payable to the Registrar.

Annual Report for the FY ending 31.03.2017

Dear Friends.

Vanakkam. It is my proud privilege to present this Annual Report before this august body, in the 14th AGM, being held on June 24.06.2017

1.0 **Introduction:** This Bureau was registered under Societies Act on 24th Sept. 2002, with Reg. No. 370/2002. But it was launched on 3rd March 1996. As such the Bureau steps into 22nd year.

As you know that this Bureau is marching with its pioneering service to the Elders of the Society. It is worth remembering on this occasion, the valuable contributions made for the growth of the Bureau by founding fathers and the office bearers / EC Members (past and present) as well as the support extended by our members, Networking Associates, NGOs & Govt. We have been representing vital issues and grievances concerning Senior Citizens, to the Govt. both State & Central.

2.0 **Membership:** With our earnest efforts for sustained development the strength is: IM (Institutional Member) - 1, DM (Donor Member) - 2, LM (Life Member) - 326, AM (Annual Member) - 4, HM (Honorary Member) - 76 = total 409.

3.0 Meetings.

- 3.1 The last AGM was held at 10.30 a.m. on June 24, 2016, (Sunday), at Library Auditorium, Ethiraj College for Women, Egmore, Chennai- 8. The minutes is read out and adopted today.
- 3.2 Commemoration of 21st Annual Day of SCB, and 13th year publication of "Link Age" was observed on 22.07.2016 at 11.00hrs. Swami Mitrananda, Spiritual Teacher of Chinmaya Mission, Chennai released our special publication entitled "Sweet 21. 11th World Elders Abuse Awareness Day was observed on 22.07.2016 at Ethiraj College for Women, Egmore. Dr. A. Nirmala Principal & Sec., Ethiraj College for Women was the guest of honor. Senior Elder Members who have citied 1000(+) moons as on 22.07.16 were honored
- 3.3 EC Meetings were held regularly every month. Core group meetings were held frequently to plan and carry out the activities.
- 4.0 World Elders Day was observed jointly with Ethiraj College for Women from 9.30 a.m. to 1.30. p.m. on October 1, 2016 at Ethiraj College Chennai – 8. Gandhian Thiru V. KALYANAM Freedom fighter and former PS to Mahatma Gandhi, Chennai was the Chief Guest. SCB Awards of Excellence were presented to Dr.V. Shanmugasundaram, former Vice Chancellor of Manonmaniam Sundaranar University and to Mrs. Dr Yasoda Shanmuga Sundarm, former Vice Chancellor of Mother Teresa University. Dean of Academics Dr. Sheela, represented the principal Dr. A. Nirmala who has to leave for a rescheduled conference at Bhuvaneshwar. She launched the project "Talk to a Granny", designed by Senior Citizens Bureau jointly with NSS Ethiraj College. She explained its features as a standing example of solidarity of youth with elderly.
